- Instances of the name "University" were updated to say "the University Community" and "University Community Planning Area" when referring to the community as a whole.
- Some maps had an incorrect depiction of the Open Space system. All maps now have the correct layer.
- Changed references of trolley stations to include transit stops.
- Changed the term "roadway" to "street".
- Minor word changes to use more approachable language.
- Removed references to "Blue Line" Trolley (now only as "Trolley") because line names can change over time.

 - S Added the word "coastal" and removed the words "ways" and "an increase in."
 - U Replaced the words "sensitive to" with "to enhance."
- Page 181: 4.2: Trails, Overlooks and Tailhead Pocket Parks
 - o C Incorporated reference to upcoming Citywide Trails Master Plan process.
 - D Added the words "and restore."

 - C Slight text edit to clarify Torrey Pines City Park will be developed in accordance with the existing General Development Plan.
 - H Modified to say, "Protect and restore Rose Canyon ecosystems and watershed habitats."
 - I Added the sentence, "Protect and restore Rose Canyon Open Space Park for education, research, stewardship, and passive recreation."
 - L Removed policy because it addresses a location outside of the Community Planning Area. Subsequent policies were renumbered.
 - o P (now policy O) added the words "completion of the Coastal Rail Trail and."
- Page 185: 5.15 D Added words "charging stations for electric vehicles."
- Page 185: 5.16 B Added the word "native."
- Page 190: Modified hatching on CPIOZ map to make freeway- and canyon-adjacent development more distinguishable. CPIOZ boundaries have also been updated.

 - Created a new scaled system for determining public space that is more tailored to the different site sizes found in the community.
